2. In the ***Bid Data Sheet ITB Clause 10.4***, in the Key Personnel, the “**Professional Master Electrician**” was corrected to “**Professional Electrical Engineer**”.

  - b. Manpower Schedule;
  - c. Construction Methods;

  - f. Bio-Data of all key personnel/construction workers to be assigned in the Project Site.

Subject: **REVISED BIDDER REQUIREMENTS FOR DEPED**  
**ELECTRIFICATION AND SOLAR PROJECTS**

The Office of the Undersecretary for Administration (OUA) thru the Education Facilities Division (EFD) is issuing a revised bidder requirement for the DepEd Electrification and Solar Projects.

The Bid and Awards Committees (BAC) of the Department of Education (DepEd) shall require bidders for the procurement of DepEd Electrification Program including Solar Electrification Projects to be a licensed contractor of the Philippine Contractors Accreditation Board (PCAB) with Registration Particulars SP-EE (Electrical Work). This requirement shall be included in the provisions of the Bidding Documents to be issued by the BAC.

Prospective contractors / bidders must have a valid PCAB License, a Registration Particular as mentioned above and an Allowable Range for the Cost of Contract to be bid prior to participating in any bidding to be conducted by the Department and to be eligible to undertake the project.

This memorandum in effect, supercedes the two previous issuances of this office on the matter.
