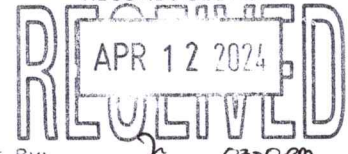

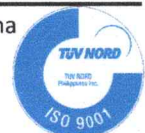
CONDUCT OF MADRASAH/ALIVE CLASSES PROGRAM ON SATURDAY

To: Assistant Schools Division Superintendent
Chief, School Governance and Operations Division
Chief, Curriculum Implementation Division

1. The global commitment to Education for All, and to provide access to quality education is a call that includes all forms of educational delivery systems. All children as rights-holders must be given quality education opportunities irrespective of their race, color, religion or culture is one of the reasons stated in DepEd Order No. 51, s. 2004. Re: "Standard curriculum for elementary public schools and private Madaris". One of the aims of this curriculum is to promote the Filipino national identity and at the same time preserve the Muslims' cultural heritage
2. To support this aim, DepEd Binan City, through the Curriculum Implementation Division, conducts the **Madrasah/ALIVE Classes Program on Saturday** for Muslim learners in the following schools: Binan Integrated National High School, San Vicente Elementary School, and Pagkakaisa Elementary School. This program is intended to promote Arabic literacy and cultural awareness for Muslim learners who are enrolled in the said schools and available only to attend ALIVE classes on Saturdays.
3. Regular teachers teaching Arabic Language and Islamic Values Education (ALIVE) classes on Saturdays may be granted Service Credit in compliance with DepEd Order No.53, s. 2003, "Service Credit may be granted in attendance/participation in special DepEd projects and activities, etc. if such are held during the summer vacation or **weekends**"
4. Furthermore, the conduct of the said ALIVE classes on Saturday is part of the expansion of the Madrasah Education Program to accommodate the increasing number of Muslim learners in the school and to cater to the request of parents to hold ALIVE classes on Saturday because of the availability of the Asatidz

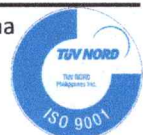
